OFFICER REPORTS

Exchequer's Report – Her Ladyship Fiona the Archer

The bank balance, as of today, is \$10,243.82.

The Public Storage March cheque has been sent out.

Justice Institute of BC invoice for January was \$157.50. The cheque has been sent out. After sending out a replacement cheque in January, for the October past due invoice, I have not had further contact or confirmation.

Cloverdale Rodeo and Exhibition invoice for January was \$735.00. After applying the remaining \$55.00 credit we have on account, the cheque was sent for \$680.00.

On the third try I have succeeded in having our account informatiion changed with EconoPro (biffies). The original invoice for Sargeant's was billed to Lionsdale, who forwarded to me. It has taken three phone calls to get the invoice change. The bill is paid. It would appear that any and all orders for biffies were being billed to one account, namely Lionsdale, because we use the same sites. Due to the confusion the accounting department has changed the name from "Society for Creative Anachronism – SCA" to "Shire of Lionsdale – SCA". What this means is that the next event steward who orders biffies will have to set up an account with EconoPro in the name of "Barony of Lions Gate – SCA". Unfortunately, they are unable to set up an account for us without an order.

The corrected invoice for the Maritime Labour Centre site fee for Baroness' has been received and paid. The original invoice was off by about two thousand dollars. Apparently a typo.

The end of year Baronial financial report to Principality and Kingdom is complete and an electronic copy went out to the Principality Exchequer on January 29th. A paper copy will be signed today and sent before next week.

The exchequer requires more postage stamps to pay the bills.
